ORDER

As per the G.O. read as (1) above, all University examination and other fees applicable to Affiliated colleges were **mandated to be increased** by 5% from the year 2019-20 onwards, with the same rate of increase to be continued for each subsequent year.

Further, as per the G.O. read as (2) above, the existing fees/charges for all services provided by Government Departments, Public Sector Undertakings, and Grant-in-Aid Institutions shall be enhanced by 5%. The said G.O. was implemented in the University as per the U.O. read as (3) above. Subsequently, as per the U.O. read as (4) above, various fees applicable to the University Departments, Schools, and Centres were also revised accordingly.

In line with the above Government Orders, the University has been implementing a 5% annual enhancement in examination and other fees for each Financial year. Further, as per the Orders of the Vice-Chancellor read as (5) above, sanction has been accorded to continue with the 5% annual enhancement in the fees applicable to the University Departments, Schools, and Centres.

Accordingly, the Vice-Chancellor, in exercise of the powers vested under Section 10(17), Chapter III of the Mahatma Gandhi University Act, 1985, vide Paper read as (6) above, has accorded sanction to enhance all University examination and other fees by 5% for the Financial year 2026-2027 by incorporating the following fee revision proposal:

The foreign currency rate for Re-verification Fee is revised from USD 62 to USD 66, subject to a maximum of USD 197 for re-verification of one programme.

The revised rates shall come into force with effect from the date of issue of this order and shall apply to all fees pertaining to the financial year 2026–2027.

Orders are issued accordingly.
